Effects from single and short-term repeated exposures to high concentrations of mineral oil mists well above applicable workplace exposure levels include lung inflammatory reaction, lipoid granuloma formation and lipoid pneumonia. In acute and sub-acute studies involving exposures to lower concentrations of mineral oil mists at or near current work place exposure levels produced no significant toxicological effects. Distillates (petroleum), hydrotreated light: Mineral spirits have produced slight to moderate skin irritation particularly with evaporation from the skin is prevented. Animal studies have demonstrated that mineral spirits produced mild respiratory tract irritation at elevated concentrations. The most common effects observed in repeated dose animal studies with mineral spirits are kidney changes that are consistent with an alpha 2u-globulin- mediated process that is not regarded as relevant to humans. Certain studies have reported effects in the liver as well as hematological or urine chemistry changes. Abuse of similar materials has been associated with irregular heart rhythms and cardiac arrest.
